In addition, as long as your Federation/organization remains a current member of the TIA in good standing and in support of the Cardio Tennis effort through education and training, your group has access to the following:

**As the Cardio Tennis representative for your country, you receive the following:**

1. Use of the logo identifying the Cardio Tennis trademark.
2. Listing on the Cardio Industry and Consumer Website as the referred contact in your country.
3. All inquiries/referrals received by the TIA, via website or phone inquiries.
4. Access to promotional materials and information developed for Cardio Tennis.
5. Permission to reproduce banners, DVDs, brochures, posters.
6. Permission to translate these materials to your language.
7. Access to current and future drills, instruction, video and Cardio Tennis articles.
8. Secure pass code to access the features on the partners website available to members only.
8. Permission to establish country's website promoting Cardio Tennis
9. Free Cardio Tennis marketing toolkit including promotional materials, drill DVDs, music CD, and marketing CD.
10. Access to training and educational documents, PowerPoint presentations.

**As the Cardio Tennis representative for your country, the following guidelines apply:**

1. TIA Affiliate must adhere to any and all trademark usage policies established by the TIA
2. Cardio Tennis workshop will be organized and held in your country within a mutually agreed time period. Training would include a "Train the Trainers" session and a "General Workshop" for the country's coaches as well as the option for a consumer/media event. This training and its related costs are the responsibility of the affiliate member. In addition, a "Masters Training" session may be organized in the U.S. by the TIA for all Cardio Tennis representatives and attendance is strongly encouraged.
3. Maintain the vision, quality and consistency of the original Cardio Tennis program as created by the TIA USA.
4. Encourage sites/coaches within your country to view DVD and partner's website: [partners.CardioTennis.com](http://partners.CardioTennis.com)
5. TIA Affiliate can only train, provide advance education and authorize sites in your country to those coaches who already hold a certification from your country or any other recognized certifying organization (i.e. USPTA, PTR) as a tennis or fitness instructors.
